Rationale	Enduring Understanding: Pre-service teachers need to understand the core components of all English communication. This is a core unit for pre-service teachers in language and literacy. The unit introduces preservice teachers to the discipline content of the Australian Curriculum: English within the content strands of language, literature and literacy. It equips pre-service teachers to assist (Prep-Year 6) students to develop literacy and a broad coherent understanding of the written and non-written forms of communication. Pre-service teachers will engage with the nature of both receptive (reading, listening, viewing) and productive (writing, speaking, creating) modes across the phases of learning. Attention will also be given to the importance of emerging forms of technological, multi-modal, and culturally-diverse textual practices in the context of globalisation. A Christian perspective will be integrated in the analysis and critique of approaches to the content of the English key learning area.
