Rationale	It is valuable for the student of linerature to have a broad historical understanding of the periods and influences which have shaped the Western literary tradition. Such an understanding is essential to provide a framework within which to appreciate the different conventions and characteristics of the major literary periods. The recognition that writers do not create works of literature in a vacuum, but respond to particular political, social, intellectual and religious influences, is also significant for a robust understanding of literature. It is important that students recognise the contribution that Christianity has made to the Western literary tradition in the past in order to recognise the need to reclaim literature as an important area of Christian endeavour in the present. This is especially true given the increasing despair of modern literature, as humankind has moved further away from an integrated worldview to the disordered, pluralistic view of the modern world. This unit is foundational for students of English literature as the knowledge and skills involved in the understanding of and reflection upon the development of the Western literary tradition is
