Rationale	The coursework units in the Bachelor of Applied Social Science address only a sample of the many relevant and important issues, topics and problems relevant to the applied social sciences. The specific interests of individual students can provide opportunities to undertake in-depth studies of appropriate topics of their own choice, where these complement the coursework program and are consistent with the overall program aims. Self-directed research studies of these kinds also have the capacity to make important contributions to the fund of applicable knowledge and expertise as well as providing students with personal and professional growth experiences, including the providing of a forum for the critiquing of a Christian worldview in a particular social sciences context.  The personal and professional development of students who engage in independent inquiry through investigatory activities is therefore a major focus of this unit.

Unit summary	This directed project unit enables the student to build upon the proposal and literature review developed in the previous research unit and to further investigate their chosen social sciences topic by completing a comprehensive dissertation on this area that is of particular interest to them.
